VICTIMS OF POISON

Body of Mrs. Chapman To Be Exhumed-Widow Cleared.

London, Oct. 29. - The home secretary, Mr. Akers-Douglas, has ordered the exhumation of the body of the last wife of George Chapman. Cortlandt, N. Y., Oct. 29.—At the close of the coroner's hearing Mrs. Maud Kiehl, the 18-year-old widow, charged with poisoning her brother-in-law, Adam Kiehl, was released for lack of evidence to connect her with the crime. It was proved that Kiehl, who was a prominent young farmer of Premble, died from strychnine poisoning.

Ten-Wheeled Locomotives.

Montreal, Oct. 28.-For the first time ince the original purchase of equipment the Canadian Pacific Railway Company is going to import locomotives from across the Atlantic. The manufacturers of the United States and Canada are overcrowded with orders for next year and the inability of the company to secure delivery when required has compelled it to place an order in Scotland for twelve tenwheeled locomotives.

ONLY ONE CHARGE GONE INTO

Voter for Monteith Marked Ballot of a Brown Supporter-Mr. Blake's Statement.

Stratford, Oct. 28 .- The first seat in Ontario to be opened by the election court is North Perth, in which the trial judges today ordered a new election after a brief inquiry and a crutiny of ballots. The trial was unexpectedly brief, for even some of the counsel engaged came prepared to stay at least for a week or two. There was, too, an imposing array of witnesses, to retain whom would have cost \$300 per day in witness fees. The court had barely opened, when counsel for Mr. J. C. Monteith, the Conservative member, who had been declared elected by a majority of two votes, proposed a conference with a view to settlement, and the result was an understanding, by which one charge would be taken up. w...ch would result in the vote being declared a tie, thus necessitating a new

election. This charge was speedily investigated. LEFT VOTE A TIE. It was shown that of two men by

the name of James Fraser, both formerly living in Stratford, one had moved outside prior to the election, and on polling day he, thinking he still had a vote in the city, marked the ballot he obtained for Monteith, and it was counted, while the Stratford Fraser, coming later, received a tendered balot, marked it for Brown, and it was not counted. This difficulty being adjusted, the

vote was left a tie, and after the two candidates had formally declared their ignorance of any corrupt acts in their behalf, a new election was ordered. The trial judges were Mr. Justice Maclennan and Mr. Justice Moss, of the court of appeal. The petitioner in the case was Mr. John Brown, the unsuccessful Liberal candidate. He was represented by the eminent local counel who have had charge of the case, Mr. J. P. Mabee, K. C., Mr. G. G. Mc-Pherson, K. C., and Mr. R. T. Harding, of Stratford. The respondent was represented by Mr. S. H. Blake, K. C., and Mr. Edmund Bristol, Toronto, and Mr. E. Sydney Smith, K. C., Stratford. Mr. C. S. Grant, assistant clerk of the court of appeal, acted as registrar.

RESPONDENT SEEKS CONFER-

ENCE. Immediately after the opening of the court, a few minutes past 1 o'clock. Mr. Blake intimated to the petitioner's counsel that he desired a conference, and their lordships' permission was obtained to the withdrawal of all counsel, the candidates and the principal parties interested to an outer room. On their return 35 minutes later a subdued consultation was held with the court, after which one of the counsal announced to the members of the press that the respondent's representatives had offered to open up the seat at once by consent, but that their lordships equired that some evidence be ten dered to justify that act. It was then decided to give evidence respecting the Fraser charge.

Toronto, Oct. 29.-Mr. Johnson, s mine boss from Shamokin, Pa., passed through Toronto yesterday on his way to work in the British Columbia soft coal mines for Ellis Rogers, in whose employ he was in Pennsylvania, 27 years ago. Mr. Johnson said that his mine at Shamokin had 1,360 feet of water in it, and that it would take two years to pump it out before work could be resumed. While the other mines in the district were not quite so badly flooded as this one, yet most of them were more or less in a state of being submerged and it would take a long time to get them in a condition for working. He stated that not half the men had yet gone to work. There was difficulty all through the region over the taking back of the men. He said that it was almost cer-

tain that there would be further trouble by next spring. Pope Interested in Canada.

Rome. Oct. 29.-The Pope today received Archbishop Bruchesi, of Monreal, in private audience. The pontiff showed great interest in Canada and spoke in flattering terms of Premier Laurier.
