

BRUSSELS SPROUTS:

During 1989, French imports totalled 1,437 tonnes and exports 1,804. All imports came from other EEC countries; imports from Canada would face a tariff of 18 percent.

CAULIFLOWER:

Imports during 1989 amounted to 8,628 tonnes and exports to 6,206. Ninety-eight percent of imports were from other EEC countries. Non-EEC suppliers were Mexico (121), Poland (50), USA (19), Turkey (4) and Morocco (3). Canadian imports would be subject to an 18 percent tariff.

The bottom line is, of course, whether Canadian duty-paid prices for these products could be competitive with other sources.
