Inquiries of the Ministry

Hon. John C. Munro (Minister of National Health and Welfare): I have read some of the reports to which I believe the leader of the New Democratic Party has referred. After meeting many of the provincial welfare ministers a few weeks ago, I can say that this is not a prevalent practice throughout Canada, though it may be happening here and there. To the degree that it is, I shall be pleased to talk the matter over with the welfare ministers whom I shall be meeting shortly.

HEALTH

INCLUSION OF PARAMEDICAL SERVICES UNDER MEDICARE

Mr. Doug Rowland (Selkirk): My question is directed to the Minister of National Health and Welfare. May I ask whether at his conference last week the question of including certain paramedical services in the national medicare plan was discussed and, if so, whether any progress was made toward a consensus on this matter?

Hon. John C. Munro (Minister of National Health and Welfare): Yes, Mr. Speaker, it was discussed, and it was decided we should examine this question of the extension of coverage together with the financial implications of the present sharing arrangements and of health insurance programs generally.

Mr. Rowland: Is the minister in a position to tell us when we might expect a more specific announcement?

Mr. Munro: Well, we agreed to look into this whole matter with the provinces over the course of the next few months, and until we are in a position to reach a more definite conclusion I would have nothing more helpful to advise the House.
