Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, I rise not to oppose the motion but in order to make a few comments of a very non-partisan and noncontroversial nature in respect of the bill, particularly with regard to two aspects relating to unemployment, the winter works and LIP programs which were designed to reduce unemployment. Certainly, as I say, I do not propose to oppose the measures that are put forward so far as the winter works program is concerned. I have consistently maintained that in a country such as Canada there is a need for special programs relating to employment in winter in an effort to mitigate to some extent the amount of unemployment that ordinarily develops within Canada as a result of winter. Of course, the winter works program was originally inaugurated under the government of my friend, the right hon. member for Prince Albert (Mr. Diefenbaker). I must say, in connection with the supplementary estimates on this item that the announcement of December, I believe it was or late in November, by the government that it would embark on a program of winter works did surprise me somewhat in view of the very harsh condemnation of a winter works program for Canada by this government over a period of at least some two or three years.

Second, I must comment that this announcement came extraordinarily late in order to be as effective as it might have been for this winter following a rather constant position taken by the government that it would not involve itself in any program this winter. So I can only conclude that the announcement of the program was the result of some kind of conversion and was really not induced by conviction. Third, in passing I must comment that, since it covers some three years, the method of introducing this program through the supplementary estimates seems to be a rather strange proceeding. Above all, however, I wish to emphasize as firmly as I can in this Chamber that the winter works program and the supplementary funds voted for the LIP programs are, of course, no substitute for an adequate level of employment in
