by both parties. I hope that the firefighters are going to accept this proposal.

Mr. Oberle: A supplementary question, Mr. Speaker. Can the minister tell the House when the proposal will be put to the B.C. firefighters and whether the proposal recognizes regional disparities and regional differences?

Mr. Marchand (Langelier): Mr. Speaker, it is a proposal which is a compromise, and it has been negotiated between the alliance and the Treasury Board. I think it is not proper to reveal the terms before the membership has had an opportunity to consider them.

STRIKE BY FIREFIGHTERS AT VANCOUVER AIRPORT-POSSIBLE PROPOSAL CONCERNING REGIONAL PAY RATES

Mr. Steven E. Paproski (Edmonton Centre): Mr. Speaker, my question is also for the Minister of Transport. At the Public Service Alliance negotiations with the Treasury Board regarding the airport firemen's dispute was there a firm offer of regional rates presented to the bargaining committee and if not, why not?

Hon. Jean Marchand (Minister of Transport): Mr. Speaker, a proposal was made on the part of the negotiating team and has been submitted to the workers who are going to vote on it. After that, you will know exactly what it is.
