## NATURAL RESOURCES

CALL FOR ESTABLISHMENT OF JOINT COMMITTEE TO STUDY DEVELOPMENT OF NORTHERN RESOURCES—MOTION UNDER S.O. 43

The Yukon, the Mackenzie Valley, the Beaufort Sea and Arctic Island hydrocarbon and mineral resources are being increasingly delineated. The ownership rights, further discovery and delineation, development and transportation of these vast resources to markets present Canada with a major challenge and will set the stage for the future well-being of the northern half of this nation. Therefore I move, seconded by the hon. member for Western Arctic (Mr. Nickerson):

That a joint committee of the Senate and the House of Commons be established to examine and report on the ownership rights of such resources, the programmed development of such resources, the appropriate transportation systems for delivery of such resources to markets, and the desirable nature of community development in the high Arctic.
