**Mr. Chris Speyer (Cambridge):** Mr. Speaker, my question is for the Deputy Prime Minister. The Deputy Prime Minister will know as a result of the furore concerning criticisms of the Tax Department that the Prime Minister's Office has established a small group of individuals designed to advise the Minister of National Revenue with respect to the criticism that has been levied at his Department.

Mr. Tom Axworthy, the principal secretary, says that the Prime Minister's Office is designed for partisan purposes. In light of the tactics of investigation, and in light of the attempted smear and the muck raking with respect to the Leader of the Opposition, how can any Members of this House repose confidence in the fact that we will be immune from criticism with respect to criticism of the Revenue Department when the Prime Minister's Office is constantly investigating the Leader of the Opposition and other Members of this House?

Hon. Allan J. MacEachen (Deputy Prime Minister and Secretary of State for External Affairs): Mr. Speaker, the question is purely rhetorical. The Hon. Member does not ask anything. He makes a number of charges with which I have dealt already. There is no investigation whatsoever into the personal lives of Members of Parliament. The Hon. Member repeats the claim again. Why? There is no such effort. Is the Hon. Member surprised that the Prime Minister's Office is interested in the politics of Canada?

**Mr. MacEachen:** It is, and will continue to be. I am sure if that never-never land happens and we have a Tory Government again, the Prime Minister of that Government would be interested in the politics of Canada and would be very interested in what the Leader of the Opposition would be doing in that very, very distant time.

I should like to assure him as well that, whatever the political partisanship criteria may be, they are never a determining factor as to whether a taxpayer return will be audited or not.
