THE BROOKVILLE FORGER.

A Large Number of Capitalists Became Victims of Professor Kaufman's Operations.

BROOKVILLE, Feb. 1.—The arrest of Prof. A. C. Kaufman on Tuesday night has brought to light a series of the most audacious and daring forgeries ever perpetrated in Canada, and show that the operations have extended over a period of about fifteen years.

The victims whose names are not yet known in full, but they are supposed to amount in all to between \$750,000 and \$1,000,000.

Persons who are tolerably well informed in the matter say that it will fully reach the latter amount. Facts which have come to light in connection with the forgeries leave no room to doubt that they have been going on for years.

The plan of operation.
