A number of prominent Canadians were travelling on a train some months ago. Peter Mitchell being one of them. Some of them were returning from the ceremonies connected with the unveiling of a Sir John A. Macdonald statue that had just been erected in Hamilton we believe. Naturally, the statue and its subject were referred to, and Mr. Mitchell took occasion to say that no such honor should be paid to the memory of so bad a man as Sir John A. Macdonald; and he proceeded to give his reasons therefor. They were strongly expressed to say the least, and included statements of a personal as well as a political character, which gave quite a shock to the friends of the dead statesman who heard them. A few days ago the letter appeared in the Toronto World and Mr. Mitchell sent a telegram to Montreal stating that he had nothing to do with its publication. The Lat: Jo in Livingston.

We observe that nearly all the papers have fallen into the error of stating that it was after Mr. Livingston established the St. John Watchman that he went to Montreal and became editor of the Times. It was in 1874 that he became editor of the Times, and he went from that paper to St. John to establish the Watchman, which he conducted until the great St. John fire, which wiped it out of existence. Between the severance of his connection with the Tribune and his becoming editor of the Times he was in the service of the Dominion Government, under the Marine and Fisheries department—a fact that seems to have been overlooked by all the papers, excepting the ADVANCE.

Some St. John papers erroneously say that Mr. Livingston returned to the city with the Telegraph as editorial writer, and that he before, as all his energies were required to conduct the financial end of the business. Mr. Elder increased Mr. Stewart's salary and placed a great deal of the editorial work on him, and the paper did not prosper. A fine editorial, except what Mr. Elder and Mr. Stewart wrote for it, as long as the paper remained on its feet.

Mr. Livingston originated a regular staff, instead of the paper going to print in the evening, the forms were kept open till daylight and the paper had the latest despatches and the latest local news to be got. Mr. J. L. Stewart, who was night editor of the paper, rarely left the office after 10 o'clock.

Mr. Elder had gone to Ottawa on a flying visit, to get in touch with men and things at the capital, and Mr. Livingston, finding that the cares and duties of the counting-room kept him from editing, writing, and so on, Mr. Stewart, at 11 o'clock, sat at a desk and wrote a letter to Mr. Stewart, asking if he would be a leader for to-morrow's paper. It was the first time he was asked to do so, but the night editor promptly said of course he would. Well, said Mr. Livingston, you have been watching the Common Council proceedings of late, you know how badly the Council has been managing the corporation business; suppose you write a leader on the Common Council. Very well, said Mr. Stewart, that was a good enough theme for him. Then without another word of discussion as to the manner of dealing with the subject, Mr. Livingston went home. That was his way. If he had confidence in a man he trusted him, and left him to his own method. When Mr. Stewart entered the office the next afternoon he found Mr. Livingston and progress of his hand, reading the leading article. "There have been a few alterations in the program," he said, "wanting to help up the paper with more threatening libels than
