

was appointed by his Sovereign as a Knight of Grace, and he joined the Priory of the Order of St. John in Canada where I served with him for many years. He was an outstanding figure upon whom you could always depend to play his part in anything that was necessary for the organization. He has left an honourable record; he did so many things well. It was a source of wonder to me as a businessman that he could be so successful in business, having so many interests and doing so much voluntary good for the people around him. He was in the forefront of practically every movement designed to elevate the tone of the people of his province.

He knew tragedy and suffered infirmities in the last few years of his life, but he had what I might call a marine attitude. He was president of a towing company, and president of an engineering and shipping company in British Columbia, and he stayed on deck despite the fact that he was infirm, and he fought to the last. When last I saw him here my opinion was that he would not last very long, but he still had hopes for the future and he still was optimistic about life in Canada.

The McKeens of Nova Scotia will be pleased to know that he was so well liked and highly esteemed here in the Senate. He has kept the name clean and great on the west coast. With other honourable senators, I wish to express to Senator McKeen's widow and family the sincere sympathy of my wife and myself. And now that he has been gathered to his fathers, their faith will help to sustain them in their sorrow.
