SEED POTATO MISSIONS TO CANADA

Question No. 2,405-Mr. MacDonald (Egmont):

1. What attempts have been made by the Department of Industry, Trade and Commerce, to increase the number of seed potato missions to Canada in 1968, 1969 and 1970?

Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce): 1. The Department of Industry, Trade and Commerce is sponsoring a Seed Potato Mission from Israel during the summer of 1969 and is considering the possibility of a mission to South America sometime during this fiscal year. In 1968 the Department sponsored a Seed Potato Mission from Romania. In 1968 the Department also arranged visits to Venezuela and Cuba by a Department of Agriculture expert to look into plant health problems in seed potato shipments. The Department's Trade Missions Programme for 1970 is presently under consideration.

2. The Department has invited a number of countries in which markets or potential markets for seed potatoes exist to send representatives to visit seed potato areas in Canada. The following have accepted: Greece, Argentina, Jamaica, Uruguay, Italy, Venezuela, Portugal, South Africa, Romania and Israel. 3. Yes.
