An Act further to amend An Act intituled "An Act to incorporate certain persons under the name of the Richelieu Company."

WHEREAS the Richelieu Company have by their petition representation in sented that no provision is made in their Act of Incorporation in reference to the qualification of persons chosen as Directors, and they are desirous that the said Act should be amended so as to define and 5 establish the said qualification, and also in other respects; and it is expedient to grant their prayer; Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:—

- 1 No person shall be qualified to be elected or to hold office as a Qualification 10 Director, unless he shall hold, in his own name, twenty shares in the of Directors. Capital Stock of the Company, on which all calls shall have been duly paid. Provided, however, that this clause shall not go into operation until the next annual and general meeting of the Stockholders to be held after the passing of this Act.
- 2. The fifth section of the said Act is hereby repealed, and the Number of following substituted therefor. "Each stockholder shall be entitled, votes to which at all general or special meetings of the Company, to one vote for every share which he shall have held in his own name at least one titled, month previous to the time of voting; and all questions brought bestockholders at any such meeting shall be decided by a majority of the votes of the shareholders then present in person or by proxy, subject, in case of an equality of votes, to the casting or double vote of the President, or Director presiding at such meeting."
- 3. Any person becoming a shareholder may constitute and appoint Appointment 25 some other person his Attorney to accept transfers of shares in the ct Attorneys capital stock of the Company, to vote in respect of such shares, to by Shareneceive dividends and bonuses, to sell and transfer any such shares, or for any of such purposes, such appointment to be in the form prescribed by Schedule A, annexed to this Act, or to the like effect.
- 30 4. This Act shall be deemed a Public Act, and the Interpretation Public Act Act shall apply thereto.
