The Act 19 Vic., cap. 12, intituled "An which report being again read at the Clerk's Act to authorise the Government to prohibit the exportation of Saltpetre and other Chemical Salts," be severally allowed to expire.

Resolved, That a Committee be appointed to prepare and bring in Bills pursuant to the above reported Resolutions.

Ordered, That the Hon. the Colonial Treasurer, Mr. Muirhead, Mr. H. Haviland, Mr. Macdonald and Mr. Clark, do compose the said Committee.

The Hon. the Colonial Secretary, from the Committee appointed last Session, to examine and report this Session on the Petition of divers inhabitants of Townships 23 and 24, presented to the House the report of the said Committee, at 10 o'clock.

Table, was agreed to by the House, and is as followeth:-

Your Committee appointed to inquire into the expediency of building a Bridge over Hunter River, Rustico, have to report, that from the great depth of water in the channel and the width of the river, a very large outlay would be required; further, the number of persons that would travel over the said bridge is not sufficient to warrant so large an expenditure as would be required to erect the bridge; but your Committee would recommend a small sum to be expended in procuring a scow and to encourage a person to keep the said ferry, especially as many persons cross the river on Sundays to attend church and chapel.
