

25 PER CENT PAYMENT TO HOME BANK DEPOSITORS

CURATOR MAKES OFFICIAL REPORT TO SHAREHOLDERS

Home Bank Will Make Advance Payment of 25 Cents.

GIVES STATEMENT

Canadian Press Despatch. Toronto, Sept. 30.—The early payment of 25 cents on the dollar to depositors in the Home Bank of Canada has been decided upon. The payment will be made through the other chartered banks doing business in Canada. This announcement was officially made tonight by A. B. Barker, curator of the Home Bank of Canada, who is engaged in completing his report on the affairs of the bank now under suspension. The payment of the dividend on the deposits has been arranged through the Canadian Bankers' Association, the president of which is Sir Frederick Williams-Taylor, president of the Bank of Montreal. Sir John Aird, vice-president of the Canadian Bank of Commerce, is vice-president of the Canadian Bankers' Association. The plan suggested is that depositors assign their deposits in the Home Bank to the bank at which they intend to draw the initial payment, or open a new account.

The decision to pay an initial dividend of 25 cents was announced by Mr. Barker in the following brief statement: "Any estimate of the value of the assets of the Home Bank of Canada and probable amount of the dividend must be purely guesswork at this juncture. In view of the fact that realization of the assets will probably occupy a considerable time, it is highly probable that the banks will arrange to advance an amount to permit of an early payment of 25 cents on the dollar to depositors on account of their claims."

Words have come from Ottawa it was learned tonight demanding that there be a speeding up of the report, and that it must be in the hands of the government by Wednesday next in order that a full public inquiry be set in motion.

GERMANS PREPARE CAPITULATION NOTICE

French Will Not Withdraw From Ruhr Until Internal Situation Clears.

Special Cable to The Advertiser. London, Sept. 30.—Germany will give formal notice of her surrender to France next week.

Contrary to expectations, however, French troops in the Ruhr will be increased in spite of official despatches. Germany's internal situation is critical. Immediately the order to resume work is given the occupational forces will take no chances by premature withdrawal, and will be pushed up to the border lines between occupied and unoccupied Germany, ready for any eventuality. When the internal situation clears a gesture of reduction in the stringency of the occupation is in order from France. This is understood to be the view of official British view of what will happen. An international conference will follow.

The village council is seeking to meet these related scruples of the hydro commission, and it is expected an early vote will again stress the wishes of the people very emphatically.

HOLD FUNERAL SERVICES FOR VICTIMS OF DROWNING

Maggs was a member of No. 2 Company, 2nd Canadian Machine Gun Brigade, the local unit, and Wynne served with the imperial forces during the war. Ex-service men turned out in large numbers and marched from the armories to Parker Street Church to take part in the service.

The parade was under the command of Lieut.-Col. C. S. Woodrow. A firing party for the graveside was selected from the machine gun company. Pallbearers were supplied from war veterans for Wynne, and from the Sons of England Lodge for Maggs.

GOVERNMENT REPLIES TO SHAREHOLDERS

Government Declares "Every Dollar of Railroad Obligations Will Be Met."

ISSUE PAMPHLET

Canadian Press Despatch. Ottawa, Sept. 30.—"Through it all, the Dominion has kept faith with capital and Canada has honored, and will continue to honor, every dollar of her obligations."

This is the final sentence in the statement issued simultaneously here and in London, England, by the Dominion Government in regard to the claim for Grand Trunk preference and common shareholders for compensation allowance, to an amount unofficially placed at \$25,000,000.

The statement contains no indication that any compensation allowance will be paid, but, it is stated that "Every dollar of her (Canada's) obligations in respect to transportation is being met by her limited population who may well be excused if they find themselves unable longer to go outside the bond, so far as railway charges are concerned."

Charge Rebutted.

The twenty-five millions mentioned as suggested in the request for compensation allowance is described by the Government as roughly equivalent to a "ratio of thirty, twenty and ten for the first, second and third preference shares and common shareholders respectively."

The charge that the board of arbitration was biased is rebutted by the statement that the most unpartisan of the G. T. R. management and second preference, third preference and common shareholders representative, Hon. W. H. Tait.

The Dominion government statement is made public in two pamphlets, one of which contains a brief summary of the general course pursued by the authorities, the other covering the case in much more detail.

Not Profitable.

"Running through most of the articles criticizing action of the government," says the shorter pamphlet in part, "there is the assumption that the government has acquired from the Grand Trunk a profitable enterprise, and that the profits are being diverted from the English shareholders to the treasury of the Canadian government. The government has not acquired from the Grand Trunk a profitable enterprise. They acquired a bankrupt concern, which they had to push up to the point at which it last confessed its inability to carry on its work. Every day and every hour since the Grand Trunk property came into the possession of the government it has been a liability and not an asset, a burden upon and not a benefit to the treasury of Canada."

DISCOVER THAT SOVIET ORGANIZED REBELLION

Capture of Ferdinandovo Puts An End to Communist Movement.

Sofia, Sept. 30.—Documents found on Communist prisoners taken in the capture of Ferdinandovo afford undeniable proof, says a government statement, that the rebellion was organized and executed with the active assistance of the Moscow Soviets. The bodies of 208 Communists were found inside the Berkovitsa lines after that place had been stormed by the government troops. Six hundred rebels were captured, the survivors fleeing toward the Roumanian frontier.

The Roumanian government has officially informed Sofia and also the frontier authorities that all Communist soldiers seeking refuge in that country will be turned back at the border. The notice adds that a division of troops has been ordered to the Bulgarian frontier to drive back the rebels.

The capture of Ferdinandovo by the government forces yesterday, it is asserted, marked the complete collapse of the Communist movement.

OFFICIAL'S DISAPPEARANCE AROUSES NEW HAMBURG

Criticism From Forest City Causes Dropping of History

Canadian Press Despatch. Toronto, Sept. 30.—Because of complaints alleging that it was "British in its viewpoint," "A History of Europe—Our Own Times," has been stricken from the list of high school histories approved by the Ontario Department of Education. The criticism of the volume originated in London, Ont., and assumed such proportions that Premier Ferguson was asked Saturday to make an investigation into the matter. The dropping of the work from the list of approved books for school use followed his inquiry.

The book was written by J. H. Robinson and Charles A. Beard, citizens of the United States. One point in which it was criticized was that in giving a brief review of the Indian Mutiny it omitted the incident of the Black force of Calcutta, but stated that at one point "The frenzied English showed themselves as cruel as the natives." It was further complained that in describing the first battle of the Marne, it lauded Joffre and the French, but made no reference to the English division. In its account of the World War, it was finally charged, it made no separate mention of the Canadians.

The work was not one of the prescribed texts of the Ontario Department of Education, but was merely a book approved for use.

Missing Editor of Tilbury Suffering Loss of Memory Found In St. Louis By Pastor

W. A. Shaw Returns To His Home Worn by Unusual Experience.

Tilbury, Sept. 30.—William A. Shaw, 61, editor of The Tilbury Times, missing eight weeks, has returned, a changed man.

On a clue provided by his brother, M. A. Shaw, of Portland, Oregon, he was located in a private home in St. Louis, Missouri, and brought back to Tilbury by Rev. Dean Dobson, pastor of St. Andrew's Anglican Church, Tilbury.

After preferring not to talk about the incident, Dean Dobson told The Advertiser tonight that the editor had suffered from amnesia, or loss of memory, but had regained a street memory in a flash when the familiar face of the minister met him in the St. Louis home.

Shaw told Dean Dobson he did not remember leaving Tilbury, and did not know how he had reached St. Louis.

At present Shaw is under the care of Dr. M. Sharpe of Tilbury. The wanderer is reported to be in poor health as the result of his experiences. He had not been at the St. Louis home long when Dean Dobson found him, the proprietors of the boarding house.

Editor Disappeared.

Eight weeks ago, Aug. 7 to be exact, Shaw disappeared. At once a search of Western Ontario began. As days passed the search reached international proportions.

His wife appealed to newspapers throughout the country to aid in the search for him. Descriptions and photos were broadcasted. The wife, not knowing the reason for the disappearance, even resorted to a personal appeal to her husband, holding the slim hope that it might reach him.

A few days after his disappearance he was reported in Chatham, but investigation of this report brought no results.

During his absence, his wife Elizabeth, and the staff of the Times have been "putting out" the paper each week, praying that the editor might return soon.

When the clue to his whereabouts was provided by the brother, Dean Dobson volunteered to investigate it. He went to St. Louis and there he found the editor, who had been in the city for several weeks. World of Strangers.

While Shaw had lived in a world of strangers. Nothing that met his gaze brought back his memory. To him, it is said, there was nothing familiar about the city, and he had taken the magazine out and didn't know a bullet was left in the gun.

Shaw was reported in St. Louis Thursday, Friday, Dean Dobson found him. At 10:30 o'clock his motor car, and relatives were at the station.

Under Doctor's Care.

Haggard, in fact almost dead tired from the strange life he had led, Shaw was taken immediately to his home and placed under a doctor's care. It will be weeks, his physician said, before he can be discharged, and to take charge of his paper again, Dean Dobson believes.

The editor looks older than when he left Tilbury. Where he has lived, what difficulties he has encountered in his bewildered wanderings halfway across the Gulf of Mexico Shaw does not know, he told the dean.

Today he is much relieved, although fatigued.

His visitors are being denied entrance to the Shaw home. His physician states he must have complete rest in order that he may recuperate rapidly.

In a few weeks, it is believed, he will be able to take up the thread of business life, which snapped eight weeks ago, when driving his motor car beyond his comprehension, he set out from his home and wandered through a world, which to him seemed strange, like a ship without a rudder.

INDIAN MARITAL TROUBLES IN WALLACEBURG COURT

IS GREEN AT THE GAME, SO ONLY FINED \$500

Stratford Man Caught With Forty-One Bottles of Corby's in Goderich.

Special to The Advertiser. Goderich, Sept. 30.—Thomas Reid of Stratford was fined \$500 on Saturday by Police Magistrate C. A. Reid for having liquor in other than a private dwelling. He pleaded guilty to the charge. Magistrate Reid said Reid had considered making the fine \$1,000, but since Reid's first offence, and his actions showed him to be a "greenie at the business," he fined him \$500.

Reid, who is about 25 years old, told the court that he had met a party in Detroit last April, and had arranged to purchase from him three and a half cases of whiskey. This was done, and Reid parked the whiskey under a bridge in a bush road, three miles south of the city, where it stayed until last Wednesday. Reid said he knew only to him as "Wild Jimmy," \$104 for 41 bottles of Corby's whiskey. Reid had been unable to get rid of the stuff in Stratford, so last Thursday he planned to take it to Detroit, in an automobile owned by his brother, John Chippewa Indians at Walpole Island. It was his intention to go by back road via Goderich, to Sombra, leave the whiskey there and go on to Detroit. He received a tip, he explained, that he might be able to dispose of some of the whiskey, but he was not able to get in touch with his man before Inspector W. T. Pellow took him in charge with the 41 bottles of "hootch."

WHAT WOULD GOD DO WITH ROBBERIES?

Rev. William Beattie Deals With Recent Toronto Bank Hold-Ups.

DESCRIBES WAR ZONE

"What Would God Do With the Bank Robbers?" was the subject of Rev. William Beattie's sermon at the First Presbyterian Church last night.

His sermonette, which preceded the main sermon, was a descriptive talk on the restoration of the war-torn fields of Belgium and Northern France. In this discussion, Rev. Beattie said that there is something more than interesting in a Canadian's visit to this district. Canadians feel that they have an interest, or a right in the land for which they fought, and that they feel less like strangers while in Belgium than in almost any other part of the globe. He mentioned the beautiful monuments and churches which have been erected in memory of Canada's finest sons as fostering this feeling, and also in their hearts the people of Belgium really appreciate the great sacrifices which were made on her behalf.

Discusses Robberies.

In his regular sermon, Mr. Beattie discussed the recent bank robberies in Toronto from several angles. Taking first the side of the question which deals with the law of the present civilization, he stated that under this heading the bandits should be put down and treated with the utmost severity.

"Our laws, designed to protect property and life, are based on the Ten Commandments and the one commandment, 'Thou shalt not steal' is too plain and obvious a command to permit of any least doubt. It is for the protection of the police of Toronto and all our cities, as well as the American police at the border, are making every effort to bring the guilty men to justice," he stated.

"Occasionally one hears of the commandment, 'Thou shalt not plunder,' and evidently get away with it. This is not the case. In the matter of publicly-owned utilities, no doubt, we are all communists to a certain extent. It is in the matter of privately-owned property we have scriptural authority for the right of any man to hold in his own hands as much goods and property as his industry or birthright may bring him.

Are Outlaws.

"The bandits who enter, plunder, and evidently get away with it. This is not the case. In the matter of publicly-owned utilities, no doubt, we are all communists to a certain extent. It is in the matter of privately-owned property we have scriptural authority for the right of any man to hold in his own hands as much goods and property as his industry or birthright may bring him.

"Going back to the Scriptural side of the question, we find that although God gives us authority for our laws, he has other ways for dealing with bandits. Robbery is only one form of crime, but in His great justice God treats all men as sinners, but not select one crime or one misdemeanor on which to base judgment. Not a single sin, but the balance of good or evil, and the character which decide their ultimate judgment," he said.

In discussing the angle of the subject, he pointed out that not punishment, but the redemption of the sinner was God's purpose in reclaiming and pursuing wrongdoers.

He referred to a recent cartoon of the German president, throwing aside a scroll entitled "Passive Resistance," and turning towards a road studded with bayonets, emblematic of the fact that Germany will have to retrace her footsteps, and seek to regain her moral position among the nations.

"In the same way," said Mr. Beattie, "the Toronto bandits will have to retrace their lives and recover the damage they have done. Bandits and thieves mark the way back to the law, and the difficulties and sorrow encountered in the process of reformation are exactly commensurate with the gravity of the misdeed."

CHARGED WITH OBTAINING UNLAWFULLY \$2,500 TOOL

Wallaceburg, Sept. 30.—Colin Campbell was charged before Magistrate Carscadden this afternoon with obtaining \$200, and a beet cultivator valued at \$2,500, by false pretences, inasmuch as he represented that some pigs sold by him to a man named Dunlop were free from encumbrance, whereas at the time the sale was made there existed a chattel mortgage held by the Bank of Montreal. He was remanded until Monday and given the opportunity of obtaining bail in \$1,000 and two securities of \$500 each. Failing this he will await his trial in jail.
