Cannot be moved if it proposes to leave out all the words of such proposed amendment, 6638-39

Eliminating main motion, out of order 6681

Embodying terms of sub-amendment, already voted upon, out of order, 6917, 6934

Expanded negatives, out of order, 6931-32

Lacking something to make it in order, correction of, 53

To refer evidence to committee, inconsistent, out of order, 733-34

Broadening the scope of original amendment, out of order, 4931

Consequential, 4930-31

Deleting words following, conveying no meaning, out of order, 4916-17

Discussion must relate only to subject matter of, 722-25

Foreign to subject matter of motion, acceptance of must not be treated as a precedent for similar future amendments, 632
