REPORTS ON MINE DUMP FIRES

### Question No. 710-Mr. Coates:

Has the federal government secured reports on mine dump fires that are available in the United States and, if so, what has been the conclusion of the reports in the elimination or containment of such fires?

Hon. Jean-Luc Pepin (Acting Minister of Energy, Mines and Resources): The mines branch, of the Department of Energy, Mines and Resources, reviews United States reports, principally by the United States bureau of mines, on mine dump fires, as they are published.

The conclusions vary, dependent on circumstances. The most successful control of mine dump fires has been experienced by the blanketing of the dumps with inert material to exclude air, or by water spraying.
