## BRITISH NORTH AMERICA ACT <br> AMENDMENT RESPECTING RESIDENCE REQUIREMENT FOR SENATORS

Mr. J.-P. Racine (Beauce) moved for leave to introduce Bill No. C-182 entitled: "An Act to amend the British North America Act, 1867 (Qualifications of Senators)".

Some hon. Members: Explain.
Mr. Racine: Mr. Speaker, the only amendment to subsection (6) of section 23 of the British North America Act, 1867, consists in substituting the word "and", underlined opposite, for the word "or".

The amendment provides that a person called to the Senate to represent the province of Quebec must not only own the real estate required within the riding for which that person is appointed, but that he must also be a resident of the riding.

Motion agreed to and bill read the first time.

## JUDGES ACT

AMENDMENTS INCREASING NUMBERS OF SUPREME AND COUNTY COURT JUDGES
Hon. P.-E. Trudeau (Minister of Justice) moved that the house go into committee at the next sitting to consider the following resolution, which has been recommended to the house by His Excellency:

That it is expedient to introduce a measure to amend the Judges Act to provide salaries for two additional judges of the Supreme Court of Ontario; one additional judge of the Superior Court of Quebec; two additional judges of the Supreme Court of British Columbia; one additional judge of the Supreme Court of Alberta, and three additional judges of the county and district courts of Ontario.

5. Yes. New cost estimate $\$ 8,000,000$. The federal government's contribution to be 37.5 per cent of the cost of approved construction to a maximum of $\$ 3,000,000$.
