HOUSING

Mr. Speaker: Order, please. I doubt whether that question is in order. Unless there are circumstances of which I am not aware I do not see why the question should be in order at this time.

Mr. Speaker: Order, please.

Mr. MacInnis: Mr. Speaker, I should like to ask the minister whether he is aware of the fact that deserters from the United States army are more or less criminals under the laws of the United States and therefore not admissible to this country?

Mr. Speaker: Order, please. I suggest to the hon. member and the minister that this is a debate and I do not think the supplementary question should be allowed.

Mr. MacInnis: Mr. Speaker, I now rise on a point of order in respect of the remark made by the Minister of Consumer and Corporate Affairs. Let me suggest to the minister, in reference to the remark he made about my ancestors, that it was not his ancestors who were involved but rather the natives who were responsible for that head he has.
