UNEMPLOYMENT—MEASURES TO LOWER INTEREST RATES ON LOANS TO STIMULATE DOMESTIC DEMAND FOR GOODS

In view of the increase in the profits of Canada's chartered banks which has been brought on by the widening gap between interest rates on deposits and on loans, is the government considering any measures to lower interest rates on loans in order to stimulate domestic demand for goods?

Hon. Mitchell Sharp (Acting Prime Minister): Yes, Mr. Speaker, there has been a very sharp reduction in interest rates in Canada. One proof of this is the lower interest rates that are now being paid on government savings bonds and other government instruments.

INTEREST RATE ON SALE OF WHEAT TO PEOPLE'S REPUBLIC OF CHINA

Can he tell us what interest rate the People's Republic of China will be charged on its recent purchase of 500,000 tons of wheat, since the terms of the sale provide that a 75 per cent balance will be payable over an 18-month period?

WITHHOLDING BY GOVERNMENT OF PAYMENTS UNDER TEMPORARY WHEAT RESERVES ACT

Mr. Eldon M. Woolliams (Calgary North): Mr. Speaker, I should like to ask the Acting Prime Minister a question. In light of the statement made by the minister in charge of the Wheat Board during the emergency debate last night, will the Acting Prime Minister assure the House that the law of Canada will now be obeyed by the cabinet and carried out forthwith?

Hon. Mitchell Sharp (Acting Prime Minister): Mr. Speaker, the government of Canada, of course, observes the law.

An hon. Member: Then pay up.

Mr. Woolliams: I take it from the answer of the Acting Prime Minister that he will be directing the Minister of Finance and the minister in charge of the Wheat Board to make these payments forthwith in accordance with the terms of the Temporary Wheat Reserves Act?

Mr. Speaker: Order, please. I assume that the hon. member's supplementary question is in the form of a suggestion. May I say to hon. members that I hope we will not pursue this morning the debate that took place last night. I appreciate the importance of the matter. I believe there are a number of supplementaries on this point, but I would invite hon. members to keep in mind that we spent some time overnight on this subject. I believe the hon. member for Calgary North has a supplementary question.

Mr. Woolliams: Mr. Speaker, I was not making any suggestion. Let me put my question again. The Acting Prime Minister said that the laws of Canada will be carried out. In view of the fact that the minister in charge of the Wheat Board said there would not be any payment made, I now ask the Acting Prime Minister whether the government is directing that the payments in question under the Temporary Wheat Reserves Act be made forthwith?

Mr. Sharp: This question, as you have said, Mr. Speaker, was discussed ad nauseam, I gather, last night, and the minister gave the answer of the government behind which I stand.
