UTILIZATION OF VIAU PARK GREEN SPACE AS SITE FOR MONTREAL OLYMPIC VILLAGE—MINISTER'S POSITION

Mr. Jacques Guilbault (Saint-Jacques): Mr. Speaker, I would like to ask a question to the Minister of State for Urban Affairs.

In view of the announcement made yesterday by the Mayor of Montreal regarding the use of the green spaces of Viau park as the site for the Olympic Games of 1976, does the minister intend to avail himself of the powers given him under the National Housing Act and the Central Mortgage and Housing Corporation Act in order to prohibit the municipal government from removing these green spaces?

Hon. Ron Basford (Minister of State for Urban Affairs): Mr. Speaker, so far we have received no application from either the city of Montreal or the province of Quebec for funds under the National Housing Act for any housing related to the Olympic Village. If such an application is received it will have to meet the normal standards of lending for such housing, namely, that it makes a contribution to the community in which the housing is established, that it falls within the normal program relat-
