- 2. Not known. C.A.E. Electronics Ltd. was offered as a suh-contractor by the prime contractor in the latter's tender, which was in competition with several other possible suppliers. C.A.E. Electronics Ltd. was acceptable to the department as a sub-contractor for this work.

 - 4. No.
- 5. There was a premium paid for introducing C.A.E. Electronics Ltd. to this business. However, the amount of the premium is expected to be offset many times by the new opportunities, which have the potential to produce millions of high technology business, made available to C.A.E. Electronics Ltd. by the contractual arrangements concluded between the department and the prime contractor.
- 6. One additional machine has been purchased and there is a possibility that the Canada Post Office will require more of these machines over the next two or three years.
