

## Order Paper Questions

2. Since February, 1970, when Canada Pension Plan disability benefits first became payable, 11 contributors whose main disabling condition was asbestosis, have received disability benefits.

In so far as Treasury Board Secretariat is concerned: 1. 3. (a) What is the name and job designation of all persons in CBC who had any part in inviting or arranging for Mr. Salvatore's participation in the programme "Viewpoint" on March 20, 1975 (b) was he paid any fee for his participation and, if so, what was it?

4. Was CBC aware in advance that Mr. Salvatore would severely criticize Canada's constitutional set-up and that he would conclude his remarks with these words "I want to become a Canadian, not a second class British subject. Vive la République du Canada"?

(Cayman) Ltd., October 15, 1974 (d) Liberia, Ogden Saguenay Transport Inc., March 29, 1974 (e) Liberia, Ogden Ottawa Transport Inc., March 29, 1974 (f) United Kingdom, Athelstane Tankers Co. Ltd., March 29, 1974?

Mr. Gaston Clermont (Parliamentary Secretary to Minister of Industry, Trade and Commerce): Export Development Corporation states that: With regard to the financing agreements in question, the main shareholders of each borrower were respectively as set out in the attached Schedule.
