EMPLOYMENT OF HANDICAPPED IN THE PUBLIC SERVICE

## Question No. 3,772-Mrs. Appolloni:

- 1. How many people designated as handicapped are employed in the Public Service?
- 2. In which departments are they employed and how many are there in each?

Hon. Mitchell Sharp (President of the Privy Council): I am informed by the Department of Manpower and Immigration as follows: 1. It is not possible to determine the exact number of persons designated as handicapped who are employed in the federal Public Service. Identification of handicaps is voluntary and therefore no records are maintained. However, we can say that in February 1975, 420 handicapped people who have so identified themselves were employed as civil servants in the National Capital Region. In September 1975, Hon. Robert Andras, Minister of Manpower and Immigration announced a joint study with the Public Service Commission to promote the hiring of handicapped in the federal Public Service. In four regions, Montreal, Vancouver, Toronto and the National Capital, demonstration projects have been established. The procedure is: handicapped persons searching for employment register at the Canada Manpower Centre or the Public Service Commission; four departments in each region are participating in this study by listing jobs with the regional counsellors assigned to the study; each time a vacancy has to be filled in one of the four employer departments, the registration files are inspected in order to refer as many handicapped as possible. The candidates must be ready for employment. Thus his or her experiences will help to identify artificial barriers to employment at the end of the study. This participation is requested from the individual but no investigation of the handicap is

involved and any discussions are voluntary and entirely confidential. Such discussions will aid the counsellor in finding a job which suits the candidate and will avoid the frustration which would arise if the candidate was referred to an unsuitable job.

2. The following Departments have given the number of employees designates as handicapped in accordance with the terms of the Public Service Commission Staffing Manual—Chapter VI. They have also included those employees who have parking privileges because of disabilities. Other Departments, not listed, have no information available since it is not contained in their departmental personnel records (see Part 1).
