# STATUS OF WOMEN

ACTION TO INCREASE FEMALE REPRESENTATION IN HOUSE OF COMMONS—MOTION UNDER S.O. 43

Mr. Al MacBain (Niagara Falls): Madam Speaker, I rise pursuant to the provisions of Standing Order 43 on a matter of urgent and pressing necessity. Whereas the participation of women in politics, commerce and the professions for more than 1,000 years has been and remains unequal when compared to that of men; and whereas this state of affairs will tend to continue unless and until the representation of women in the seats of political power is more or less equal to that of men; and whereas, in the troubled times that lie ahead, for selfish reasons alone, if not for the noblest of reasons, it is imperative that we no longer perpetuate a system which tends to prevent about one-half of our people from entering the mainstream of modern society; and whereas it is acknowledged that any new program for equalization must take account of input from the grassroots level of all political parties, I move, seconded by the hon. member for Mercier (Mrs. Hervieux-Payette), and supported by the hon, member for Waterloo (Mr. McLean) and the hon. member for New Westminster-Coquitlam (Miss Jewett):

That this House unanimously accept, in principle, that it is necessary to take some innovative, direct and adequate action now to promote equal representation of women in the House of Commons by the year 1995 and that, to this end, the government be asked to appoint forthwith an all-party parliamentary task force of four women and three men to conduct an in-depth study of the matter and to prepare a report which shall delineate a course of action to promote the desired result, and that the report be tabled in this House on or before June 30, 1982.

Madam Speaker: Order, please. The hon, member is writing a book. Is there unanimous consent for this motion?
