Some Hon. Members: Order.

Mr. Simmons: I appeal to him to stop the low theatrics and to allow the legitimate work of this House to proceed. What the Opposition is asking for in this motion is a kangaroo court.

Mr. Blenkarn: Payola to continue.

Mr. Hnatyshyn: What have you got against Australians?

Mr. Simmons: I cannot oblige the Opposition's request because I do not believe in kangaroo courts and I will not be part of one. I tell the Leader of the Opposition and his merry band over there that the lynch mobs went out over a century ago.
