#### **BUSINESS OF THE HOUSE**

#### WEEKLY STATEMENT

Mr. Nielsen: Mr. Speaker, may I ask the Government House Leader to confirm the business for tomorrow and to outline the business he anticipates the House will be considering next week?

Mr. Pinard: Mr. Speaker, tomorrow we will start debate on Bill C-12, dealing with fiscal arrangements with the provinces. Monday will be an Opposition Day and I hereby designate Monday as such. Tuesday we will resume debate on Bill C-12, as we will on Wednesday and Thursday, except that if debate on second reading is completed before Wednesday, the two back-up Bills will be Bills C-7 and C-8. If debate is completed after Tuesday, the back-up Bill to Bill C-12 will become a Bill to be introduced next Tuesday, which will be the result of concurrence to Ways and Means motion No. 2.

I want to be more specific. The first item of business on Tuesday before we resume debate on either Bill C-12 or Bill C-7 will be the motions to concur in the remaining Ways and Means motions that appear on the Order Paper. That should be the business from now until the end of next Thursday.

Mr. Nielsen: Could the Government House Leader provide the House with the title—it escapes my memory now—of the Bill that will be introduced on Tuesday flowing from the Ways and Means motion No. 2? I believe it is something to do with the Minister of Energy, Mines and Resources.

While the Government House Leader is answering that question, the Minister of Energy, Mines and Resources in an official release from his office—it does not quote the Minister but quotes an aide—suggested three additional pieces of legislation to come before the House. One is to broaden the use of the Canadian ownership charge; a second is to implement Ottawa's energy deal with Nova Scotia; and the third would be designed to amend legislation covering as yet unsigned frontier exploration agreements, which will likely be tacked on to one of the Bills. I hope there will be no tacking on. I wonder whether the Government House Leader, while the Minister is here, could confirm that we will be seeing this legislation forthcoming in the future.

Mr. Pinard: Mr. Speaker, as to the first part of the question, I already referred my hon. colleague to motion No. 2. The Order Paper reads: "Consideration of a Ways and Means motion to amend the Petroleum and Gas Revenue Tax Act". That is the Bill we intend to introduce next Tuesday.

In so far as the second part of the Hon. Member's question is concerned, I will consult with my colleague, the Minister of Energy. I should be in a position to give a clearer answer in the weeks to come.
