# PROPOSED CHANGE IN WAITING PERIOD

The principle of the legislation is not to make divorce any easier but to make it easier for the parties involved, and particularly their children, who are innocent parties, to bear the consequences of marriages which have already broken down irretrievably, and to allow them to sever their legal relationship with as little stress and acrimony as possible. I think that is a very worthy objective for the legislation.

# "OPERATION BUFFALO JUMP" INQUIRY

**Mr. Jim Manly (Cowichan-Malahat-The Islands):** Mr. Speaker, my question is directed to the Deputy Prime Minister. Is the Deputy Prime Minister aware of the meaning of this term and its symbolism? Could he tell the House whether or not he thinks that this term is an appropriate one for a paper describing government policy for native people in 1985?

Erik Nielsen (Deputy Prime Minister and Minister of National Defence): Mr. Speaker, to my knowledge there are no code names used in any of the work that I and my ministerial colleagues are undertaking regarding program review. Any code names are the product of the rather overactive imaginations of the members of the Party opposite.
