## DEPARTMENT'S LETTER TO APPLICANTS FOR REFUGEE STATUS

**Mr. Sergio Marchi (York West):** Mr. Speaker, my question is directed to the Minister of Employment and Immigration. I have copies of a letter which her Department sent to thousands of individuals who are wanted for serious and violent crimes and who are being invited to apply for permanent status if they file a refugee claim.

Why is the Minister going outside the present refugee backlog and soliciting thousands of false refugee claims, 12,000 alone in Toronto, from such individuals as drug traffickers and murderers? Does she not think that this

horrendous amount of extra work will only penalize the current and legitimate refugee claims which already number 22,000?

Hon. Flora MacDonald (Minister of Employment and Immigration): Mr. Speaker, I can say to you that the Hon. Member's statement is grossly exaggerated. I can tell him that this review will include no one with regard to criminality measures or health considerations. I do want to say that the people who are involved in this process are already in the process and the place they can ask for a refugee determination is at the inquiry stage. The Hon. Member may say that certain people should be blocked from having access to that, but as long as we can guarantee security and health considerations we feel the process should be open to those who may want to ask for refugee status in this country.

## REQUEST THAT LETTERS BE RECALLED

**Mr. Sergio Marchi (York West):** Mr. Speaker, is the Minister suggesting that the drug traffickers, offenders and those with armed weapons, should be considered for refugee claims? That is not the definition of "refugee" under the UN. Is the Minister prepared immediately to recall those letters to such offensive individuals and ensure that the only individuals who can apply for the special administrative review are those individuals in the 22,000 backlog who have already submitted a claim, and not the criminals who are outside that stream?

Hon. Flora MacDonald (Minister of Employment and Immigration): Mr. Speaker, the Hon. Member does not want to hear this. I have already indicated to him that this review will not benefit those who are criminals or those with health considerations who are not allowed to enter this country.

Mr. Marchi: That is not true.
