Mr. Guy Saint-Julien (Abitibi): Mr. Speaker, my question is directed to the Minister of Industry, Science and Technology.

The Canada–Quebec Mineral Development Agreement expired in 1990. This agreement met effectively the objectives that were set by the Mulroney and Bourassa governments, but much more needs to be done in mining research and development in Quebec.

Mr. Speaker, my question is this: Will the minister confirm today that discussions are ongoing with the Quebec government to renew this Canada-Quebec agreement to support the Quebec mining industry?

Hon. Benoît Bouchard (Minister of Industry, Science and Technology): Well, this is an excellent question, Mr. Speaker.

I can confirm to the hon. member for Abitibi that the sectorial agreements with Quebec have indeed expired in March 1991. We are now exploring an agreement with the Quebec government, but resources are extremely scarce.

We have already explore the ground regarding the forest industry, as I mentioned earlier. We are looking at the possibilities, Mr. Speaker, and, depending on the outcome of our discussions with the Quebec government, we may eventually come to some form of agreement regarding the mining industry as well.

Again off-microphone the member berated the Speaker as well as members in the House.

Mr. Speaker, it is my respectful opinion that if members continue to resort to sensationalism to make headlines, this Chamber may soon become uncontrollable. I sincerely urge your intervention in this matter. Mr. Speaker, is it any wonder that the public is withdrawing its respect for politicians when politicians themselves have no respect for one another.

Mr. David Dingwall (Cape Breton – East Richmond): Mr. Speaker, I am sure the hon. member, as well as other hon. members, knows there was no intention with that particular gesture to in any way make reference to any sexism whatsoever. If it offends hon. members, including the one who has spoken, I wish to withdraw.
