

*Ordered*, That the Bill be read the third time, to-morrow.

The House, according to Order, resolved itself into a Committee on the Bill from the Legislative Council, intituled, "An Act to enable *Joseph Robinson Bawden* to be examined "by the Law Society of *Upper Canada*, for admission to practice as an Attorney and "Solicitor;" and after some time spent therein, Mr. Speaker resumed the Chair; and Mr. *Morris* reported, That the Committee had gone through the Bill, and directed him to report the same, without any amendment.

*Ordered*, That the Bill be read the third time, to-morrow.

The House, according to Order, resolved itself into a Committee on the Bill "to incorporate the *Caisse d'Epargne de la Section St. Joseph de la Société de Tempérance de Montréal*;" and after some time spent therein, Mr. Speaker resumed the Chair; and Mr. *Gaucher* reported, That the Committee had gone through the Bill, and directed him to report the same, without any amendment.

*Ordered*, That the Bill be read the third time, to-morrow.

The House, according to Order, resolved itself into a Committee on the Bill, from the Legislative Council, intituled, "An Act to repeal the Act to legalize certain assessments "in the City of *Toronto*, and to enable the said City to recover the taxes rated and "charged;" and after some time spent therein, Mr. Speaker resumed the Chair; and Mr. *Jones* (*South Leeds*) reported, That the Committee had gone through the Bill, and directed him to report the same, without any amendment.

*Ordered*, That the Bill be read the third time, to-morrow.

The House, according to Order, resolved itself into a Committee on the Bill, from the Legislative Council, intituled, "An Act to enable the Honorable *Philip H. Moore*, to "obtain a Patent for the invention of a new method of manufacturing peat into coal by "process of steam;" and after some time spent therein, Mr. Speaker resumed the Chair; and Mr. *Jones* (*South Leeds*) reported, That the Committee had gone through the Bill, and made amendments thereunto.

*Ordered*, That the report, be now received.

Mr. *Jones* (*South Leeds*) reported the Bill accordingly, and the amendments were read, as follow:—

Page 1, line 13—Leave out from "1" to "It" in line 15.

Page 1, line 19—After "him" insert "and his representatives and assigns."

Page 1, line 21—After "years" insert "in the same manner, and to the same effect "with the same privileges and under the same conditions and restrictions, and to the "same effect as the same might have been granted to the original inventor, under chapter "34 of the Consolidated Statutes of *Canada*, intituled, 'An Act relating to Patents for "'Inventions,' if the said inventor had been a Subject of Her Majesty, residing in *Canada*, "when he discovered such invention."

Page 1, line 30—After "operation" insert the following as Clause A.—"Before any "Patent is granted under this Act, the Petitioner shall give one month's notice in the "Official Gazette of their intention to apply for the same, stating the name of the "original inventor, the date of the Patent, if any, obtained in the *United States*, and such "other particulars as will sufficiently identify the invention."

The said amendments, being read a second time, were agreed to.

*Ordered*, That the Bill be read the third time, to-morrow.

The House, according to Order, resolved itself into a Committee on the Bill to enable the Canadian Loan and Investment Company, incorporated under the Imperial Companies' Act of 1862 (25 and 26 Vic., cap. 89), to sell and dispose of certain lands, tenements and mortgage securities held by them in *Upper Canada*; and after some time spent therein, Mr. Speaker resumed the Chair; and Mr. *Cartwright* reported, That the Committee had gone through the Bill, and made amendments thereunto.

*Ordered*, That the Report be now received.

Mr. *Cartwright* reported the Bill accordingly; and the amendments were read, and agreed to.
