much as the cars are not promptly returned to Canada, and such action would immediately result in producing a shortage of cars for Canadian internal traffic. The Minister of Railways has taken the matter up with the authorities at Washington and every effort possible has been made to secure

a balance of equipment.

2. The standard per diem or car rental charged by one railway to another for the use of freight cars, is at the present time sixty (60c.) cents, per day, per car, this rate being established by the American Railway Association, and we are not aware of any proposal to change the rate, neither would a change in rate materially effect the question referred to.

(a) On the strength of No. 2 Stationary Hospital, France; Assistant Director of Medical Services, Bramshott; Transferred to office of Director of Medical Services, London; Assistant Director of Medical Services, Canadian Training Depot, Shorncliffe; Officer Commanding Kitchener Military Hospital, Brighton; Returned to Canada September 10, 1917.

(b) Pay and allowances of his rank, viz., \$6.25 per diem.

Hon. Mr. ROWELL: An Advisory Board has been appointed by the Government to comply with the requirements of the "Act to amend the Proprietary or Patent Medicine Act," Chapter 66, 9-10, George V, passed last session and it is the intention of the Government to ask this board to report on Tanlac.
