NATIONAL REGISTRATION—PROSECUTIONS AND PENALTIES

Mr. DIEFENBAKER:

- 1. How many prosecutions have taken place for failure to register under the national registration scheme?
- 2. In how many cases have the penalties imposed on conviction been remitted?

Mr. GARDINER:

- 1. 177 prosecutions conducted by the Royal Canadian Mounted Police in the provinces which are policed by them; no information with respect to prosecutions in provinces which maintain their own police forces.
 - 2. Two of the above cases.

FOREIGN EXCHANGE CONTROL-JAPAN

Mr. REID:

- 1. Have any restrictions or regulations been put into effect by the foreign exchange control board in connection with Canadian funds or money to Japan, similar to that in effect to other countries?
- 2. If so, when were any such restrictions or regulations put into effect?
- 3. From January 1, 1940, and up to the time any such regulations or restrictions were made effective, what amounts of Canadian funds, moneys or credits were exchanged, bought or transferred into or for transference to Japan?
- 4. Have any requests been made since the regulations (if any), were made effective for the transference of credits, funds or moneys to Japan?
- 5. If so, (a) how many of such requests; (b) what number of these were granted; (c) the total value of the requests so granted or allowed; (d) the reasons given for the requests made?

Mr. ILSLEY:

- 1. The foreign exchange control order and the regulations of the foreign exchange control board apply to remittances to Japan in the same manner as remittances to other countries. With the exception of countries in the sterling area and countries of continental Europe, remittances to all foreign countries are on the same basis.
- 2. The foreign exchange control order came into effect on September 16, 1939. Since then there have been some amendments to the order and various regulations of the board but none of these refer specifically to Japan as distinct from other countries.
 - 3. Answered by Nos 1 and 2.
- 4. Requests have been made by residents of Canada to make remittances to Japan from time to time since the inauguration of foreign exchange control in the same manner as requests have been made for remittances to other foreign countries.

5. With respect to (a), (b) and (c), no figures are available. With respect to (d), the reasons given for the requests are the usual ones, e.g., payment for imports, payment for services, remittance of interest and dividends, etc.
