Mr. Howard: Mr. Speaker, could I pose this thought on the point of order. From my own point of view I do not subscribe to this suggestion, but it may well be that some hon. members in the house may want to put forward ideas as to what should happen to the property which differ from those mentioned by the hon. member for Kingston, as announced by the Prime Minister. Those ideas and thoughts which hon. members have by way of debate or amendment may possibly be precluded if this motion is ruled out of order. I think it is better to proceed so that views can be expressed, first about the advisability of acquiring this property—because that is what the motion says-and second. as to what should happen to the property once it is acquired. The views expressed might be quite different from those enunciated by the hon. member for Kingston.

The book dates back to 1880 and I have obtained the following information from it which should be interesting to hon. members. The book is the Canadian Parliamentary Companion and Annual Register of 1880. I believe it corresponds to our Parliamentary Guide of today.
