FARM PRODUCTS MARKETING BILL—EXCLUSION OF CATTLE AND CALVES—ACTION OF STANDING COMMITTEE

Mr. R. E. McKinley (Huron): My question is for the Prime Minister. I ask your indulgence, Mr. Speaker, since it involves a short preamble. On February 4 I asked the Minister of Agriculture whether it was still his intention to have cattle and calves excluded from the provisions of Bill C-176. He replied that it would be up to the Standing Committee on Agriculture to determine how they wished to amend the bill, but added there was general agreement—

Mr. Speaker: Order. The hon, member should ask his question. I suggest it is not quite fair of him to deliver to the House a preamble of such length.

Mr. McKinley: Thank you, Mr. Speaker. I am getting there. Yesterday, in the Standing Committee on Agriculture, such an amendment was moved by a government member and 12 of the 15 government members voted against it, including the minister's parliamentary secretary.

Mr. Speaker: Order. This is not a question; it is a speech. I recognize the hon. member for Comox-Alberni.

Mr. McKinley: On a point of order, Mr. Speaker, my question is coming immediately.

Mr. Speaker: Order, please. The hon. member knows he cannot do this. He has referred in part of his question to proceedings in a committee and this is not in accordance with the rules. At the same time, it is not entirely fair to the other hon. members who are just as anxious as he is to ask questions, particularly when there are only seven minutes left before the end of the question period. Nevertheless, the hon. member might be allowed to put his question at this point.

Mr. McKinley: Does the Prime Minister not consider this vote to represent a distinct lack of confidence in the Minister of Agriculture by the majority of government members and would he use his influence to have such an amendment accepted when the bill comes before the House?
