UNITED STATES DISC PROGRAM—MEASURES TO OFFSET IMPACT—POSSIBLE IMPOSITION OF COUNTERVAILING DUTIES BY CANADA

Mr. David Lewis (York South): May I ask the minister this question. He has told us on a number of occasions that his department and the government are working on contingency plans to deal with any adverse impact of the United States DISC program. Is he now in a position to tell us what some of these plans may be and, in particular, whether the imposition of countervailing duties by Canada against United States imports through DISC is one of the measures being considered?

Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce): I thought the hon. member was present the other day when the Minister of Finance read the budget speech which is considered by most interested people as a good reaction to DISC and other export subsidies in other countries in a positive way.

Either the minister or the Minister of Finance said in the past seven days that he would try to find out who initiated the action in the United States against Michelin. Is the minister now in a position to inform the House what company or agency of government initiated this action in Washington.

Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce): No, Mr. Speaker, I am not in a position to say that. Besides, I think I should leave the matter to the Minister of Finance.

VIEWS OF OTHER TIRE COMPANIES ON DUTY-FREE IMPORT

Mr. Edward Broadbent (Oshawa-Whitby): Has the minister received the views of the Goodyear Corporation, Uniroyal and the Dunlop Corporation, to name three firms located in Ontario and Quebec, on the Michelin case, especially concerning the right to give them tariff-free entry to the Canadian market during a limited period of time? If so, what were their views on that issue and what was the response of the government?

Inquiries of the Ministry

Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce): In a nutshell, Mr. Speaker, for a long period of time my department was trying to develop a tire plan that would incorporate some of the features of the Michelin arrangement by which certain types of tires could be imported free of tariff into Canada if more exports of certain other types of tires took place. For about a full year we tried to develop such a plan, but the companies were not particularly favourable to it. Discussions continued. We were hoping to come to some conclusions as a result of these discussions in view of the relative uncertainty accompanying the Michelin situation at this time, so we think we should hold off further discussions on the subject—

Mr. Speaker: Order, please. The minister said he would reply in a nutshell. It is a sizeable nut.
