RESEARCH ON CONTRACEPTIVE PILL—POSSIBLE IMPROVEMENT IN AVAILABILITY

Mrs. Grace MacInnis (Vancouver Kingsway): Mr. Speaker, my question is for the Minister of National Health and Welfare. In view of the fact that nine children of every 100 born in Canada are illegitimate, representing a hazardous future for themselves and a burden for the taxpayer, and as many women are reluctant to use the contraceptive pill because of its possibly dangerous side effects, could the minister tell the House what resources his department is devoting to research specifically in regard to the contraceptive pill?

Perhaps I should put it another way: normally, a question of this kind is answered by way of a statement on motions, and the minister might indicate whether he proposes to make such a statement.

Hon. Marc Lalonde (Minister of National Health and Welfare): Mr. Speaker, I will have to go back and look at the estimates of my department to find the exact figure.

Mrs. MacInnis (Vancouver Kingsway): May I ask whether the minister is considering improving the availability of the pill as recommended by the head of the Family Planning Association of Canada?

Mr. Lalonde: Mr. Speaker, the pill, like any other drug, comes under provincial administration in terms of dispensing. This is a matter that should properly be addressed to the local druggist and to the minister of health in each province.
