I would be rather reluctant to contemplate a two-price system for a number of reasons, not the least of which is that this might be open to retaliation from some of our trading partners. That is one of the difficult questions that has occurred in these discussions.

ALLEGED CONTINGENCY PLAN FOR COMPULSORY INCOME AND PRICE CONTROLS—GOVERNMENT POSITION
