#### EXCISE TAX ACT

## **EXTERNAL AFFAIRS**

IRAN—INQUIRY RESPECTING POSSIBLE LIFTING OF ECONOMIC SANCTIONS

**Right Hon. Joe Clark (Leader of the Opposition):** Madam Speaker, my question is for the Prime Minister. It concerns the imminent release of the American hostages in Iran. Could the Prime Minister indicate to this House when and under what conditions he is prepared to lift the economic sanctions imposed by Canadian governments against the Islamic Republic of Iran?

Hon. Mark MacGuigan (Secretary of State for External Affairs): Madam Speaker, we now have an agreement between the government of Iran and the government of the United States. To the best of our information, the hostages have not as yet taken off from Tehran airport. Since we said the sanctions would be imposed during the period of flouting of international law, I will certainly be recommending to my colleagues that we remove the sanctions relatively quickly. In Canada, unlike some other countries, it requires legislative action because it took legislative action to impose the sanctions. Therefore, I believe we will have to have legislation in the House to do that.

**Mr. Clark:** Madam Speaker, the Secretary of State for External Affairs will want to check all aspects of that answer to be sure that he was not inadvertently in error in part of it.

# IRAN—INQUIRY RESPECTING POSSIBLE RESUMPTION OF FULL DIPLOMATIC RELATIONS

**Right Hon. Joe Clark (Leader of the Opposition):** Madam Speaker, let me, therefore, direct a policy question to the Prime Minister. Could the Prime Minister indicate when and under what conditions he would, as the head of the government, intend to resume normal and full diplomatic relations with Iran?

#### Some hon. Members: Hear, hear!

**Right Hon. P. E. Trudeau (Prime Minister):** Madam Speaker, I really cannot add anything to what the Secretary of State for External Affairs has already said. The policy we adopted at the time of the hostage taking, first by the right hon. gentleman's government and then by mine, was in the context of putting pressure on Iran to release the hostages. It would be my thinking, and it is also the thinking of the Secretary of State for External Affairs judging by his answer, that when the hostages have been evacuated from Iran, which, incidentally, they have not yet been, we should then move toward a normalization of relations with Iran as soon as possible.
