that we proceed to the introduction and first reading of these bills today so that each may be scrutinized between now and its calling for second reading, in order to allow the Chair to consider whether or not there are defects in the bills with respect to the practices and usages of the House.

I suggest that, by unanimous consent, all the private members' public bills listed for introduction on today's order paper be deemed to have been introduced, given first reading, ordered to be printed and to stand for second reading at the next sitting of the House, subject, as always, to a subsequent examination as to the procedural regularity of each bill.

Is the procedure to which I have just referred agreeable to the House?

# Some hon. Members: Agreed.

Mr. Lambert (Edmonton West): Mr. Speaker, I rise on a point of order. While perusing the list I found at approximately No. 275—actually it appears as the second item in the first column on page 20 of the order paper—a bill which is in my name. It reads:

An act to change the name of the electoral district of Edmonton West.
