POINT OF ORDER

USE OF PRIVATE MEMBERS' HOUR

Mr. Nelson A. Riis (Kamloops—Shuswap): Mr. Speaker, I rise on a point of order to draw to your attention that on December 5, at the close of the day, the Acting Speaker said the following at page 1853 of *Hansard*:

I have received written notice from the Hon. Member for Peterborough (Mr. Domm) that he is unable to be present in the House on Monday, December 8, 1986, to move his motion during the hour for Private Members' Business. Accordingly, I am directing the Table to drop that item of business to the bottom of the order of precedence.

Since notice will thereby be removed, the hour for Private Members' Business will be suspended, and pursuant to Standing Order 39(2) the House will continue with the business before it prior to that hour until the ordinary hour of daily adjournment.

I raise this matter because I noticed, in recalling the vote yesterday, that the Hon. Member for Peterborough (Mr. Domm) was in fact in the House at the designated time for Private Members' Business. I also recall that immediately following, the Government moved to extend the hours of the sitting. Immediately, once that had taken place at second reading, the Hon. Member for Mississauga South (Mr. Blenkarn) was the only person to rise to speak from the Government benches. He moved that the question be now put which brought the extended hours to an end.

It seems to me there may be a case to be made whereby the Government might have misused its powers and the time of Private Members' Hour to manipulate the business of the House to allow just that to take place, to allow the Government to extend the hours to complete second reading of the Bill which had simply been introduced for the first time at second reading that day.

It seems to me a potentially very serious question has been raised.
