Ordered,—That, during the debate on the motion for second reading of the bill intituled "An Act to provide for the resumption of grain handling operations on the west coast of Canada", no Member except for the first representative of each party shall speak for more than twenty minutes.

Mr. Munro (Hamilton East), seconded by Mr. Mackasey, by leave of the House, introduced Bill C-12, An Act to provide for the resumption of grain handling operations on the west coast of Canada, which was read the first time and ordered to be printed and ordered for a second reading later this day.

Mr. Chrétien for Mr. Buchanan, seconded by Mr. Sharp by leave of the House, introduced Bill C-13, An Act to amend the Northern-Canada Power Commission Act, which was read the first time and ordered to be printed and ordered for a second reading at the next sitting of the House.

The text of the Message and Recommendation of the Administrator pursuant to Standing Order 62(2) in relation to the foregoing Bill is as follows:

His Excellency the Administrator recommends to the House of Commons a measure to amend the Northern Canada Power Commission to increase the number of members of the Commission from three to five and to provide for their expenses; and to provide in the manner prescribed for changes in the financial management and in the banking practices of the Commission.

Mr. Sharp for Mr. Gillespie, seconded by Mr. Drury, by leave of the House, introduced Bill C-14, An Act to incorporate the Federal Business Development Bank, which was read the first time and ordered to be printed and ordered for a second reading at the next sitting of the House.

The text of the Message and Recommendation of the Administrator pursuant to Standing Order 62(2) in relation to the foregoing Bill is as follows:

His Excellency the Administrator recommends to the House of Commons a measure to incorporate the Federal Business Development Bank as a Crown corporation and provide for its objects and powers; to provide for a Board of Directors and for the salary of the President; to provide for Regional Advisory Councils for such regions of Canada as the Governor in Council may designate; to provide in the manner prescribed for the expenses of members of the board and of each of such councils as are established and, for the fees of ten members of the board of the corporation and nine members of each of such councils; to provide in the manner prescribed for the corporation to make or guarantee loans, invest and acquire property; to provide out of the Consolidated Revenue Fund for payments to the corporation of an amount not exceeding \$200,000,000 less amounts calculated in the manner prescribed; to provide for the capital of the corporation in the manner prescribed; to provide that the corporation may issue and sell debt obligations and that it may receive loans out of the Consolidated Revenue Fund but that the aggregate direct and contingent liabilities as prescribed shall not exceed ten times the capital of the Corporation; to provide for management services out of monies appropriated by Parliament; in the manner prescribed, to provide for the staff of the corporation, a pension fund for the staff and for the appointment of auditors; to amend the Industrial Development Bank Act to increase the capital from \$75,000,000 to \$125,000,000 divided into 1,250,000 shares of the par value of \$100; to provide for the repeal of the Industrial Development Bank Act and out of the Consolidated Revenue Fund for the payment to the Bank of Canada for the par value of the outstanding shares of the Industrial Development Bank; and to provide for other consequential transitional matters in the manner prescribed.

Mr. Chrétien for Mr. Buchanan, seconded by Mr. Marchand (Langelier), by leave of the House, introduced Bill C-15, An Act respecting oil and gas in Indian lands, which was read the first time and ordered to be printed and ordered for a second reading at the next sitting of the House.

The text of the Message and Recommendation of the Administrator pursuant to Standing Order 62(2) in relation to the foregoing Bill is as follows:

His Excellency the Administrator recommends to the House of Commons a measure respecting oil and gas in
