It seems to me that in the proposition put forward in motion No. 44 we are making sure that, in those cases where it is often difficult to arrive at a decision at the outset, the benefit of the doubt, if you like, will be on the side of the applicant. I think for an immigration program, and one specifically directed to those who apply for refugee status, we really can do no less. I hope the minister will give this very serious consideration.

**Hon. Bud Cullen (Minister of Manpower and Immigration):** Mr. Speaker, after 70 hours of committee hearings, I heard all the representations made from both sides of this House.

Motion No. 42 appears to be reasonable on the surface, but I consider it unnecessary, since it is a basic tenet of legal interpretation that anything done under a statute must be reasonable, and this would certainly include the making of regulations. More important, however, it could lead to a great deal of frivolous and fruitless litigation as individuals contend that in their particular circumstances the period prescribed was not reasonable. Thus another avenue of delay would be opened up as a result of that.

Dealing with motion No. 44, the hon. member for Egmont (Mr. MacDonald), speaking on behalf of the hon. member for Provencher (Mr. Epp), conceded that the onus of proof would be reversed. Instead of an applicant endeavouring to demonstrate the validity of his case in order to secure a hearing before the board, if we accept the amendment as drafted, the board would have to grant the hearing unless it could demonstrate that the claim was fraudulent, frivolous or unfounded. This would be next to impossible, since the board would have nothing before it except the claimant's own submission. The intended effect of the screening stage would be largely negated, with all too predictable results.

Although I have listened very carefully to the comments of hon. members and have read very carefully the amendments, I am in no position to accept them.
