Previous speakers criticised, 1052-4. Thinks the Government should have kept expenditure at the figure of 1911, 1055. New taxes referred to, 1056.

McKenzie, D. D. (Cape Breton North and Victoria)-975.

Defends the attitude of the Liberal party with respect to the Budget, 975-84.

Meighen, Hon. Arthur (Solicitor General)—

Vigorously criticises the speech of Mr. Macdonald and others, 1116-25. Where do we find ourselves to-day? Has anybody seen the Grand Trunk Pacific springing forward to take possession of the Transcontinental railway? We have spent the money. We had a clause in our contract which allowed the Grand Trunk Pacific to say just what money we had to spend here and there and in what way, 1126.

Hon. gentlemen opposite do not like the present proposals. They tell us that we are endeavouring to assist our friends, as they choose to describe them, and not to collect revenue, 1127.
