that request, however. The point is that we felt it would be safer to deal with this material in this manner, by permitting it to come in if it has been cleaned and fumigated in such a way as to satisfy our health inspectors, than to put on a form of prohibition which I was told would not prohibit because of the ease with which the material could be brought in under some other item, though I agree entirely with what my hon. friend has said.

Sir GEORGE PERLEY: Under present regulations has not the Department of Agriculture some authority with regard to importations of this kind?

Mr. DUNNING: No, not in connection with industrial materials such as these.

Sir GEORGE PERLEY: In connection with the possibility of disease?

Mr. DUNNING: That is so in connection with hay and straw and that sort of thing, but not in relation to human disease.

Mr. STEVENS: Animal health is adequately protected, but human health is not.

Item agreed to.

Resolution agreed to.

8. Resolved, that any enactment founded upon the foregoing resolutions to amend the customs tariff or schedules thereto shall be deemed to have come into force on the 2nd day of May, one thousand nine hundred and thirty-six, and to have applied to all goods mentioned in the foregoing resolutions imported or taken out of warehouse for consumption on and after that date, and to have applied to goods previously imported for which no entry for consumption was made before that date.

Resolution agreed to.

Resolutions reported, read the second time and concurred in. Mr. Dunning thereupon moved for leave to introduce Bill No. 71, to amend the customs tariff.

Motion agreed to and bill read the first time.

At six o'clock the house adjourned without question put, pursuant to standing order.
