(b) Not by the federal government; (c) see (b); (d) in 1963 and 1964, the Quebec geographic board investigated the toponymy of settlements in New Quebec. Recommendations concerning certain names were received by Quebec from an independent researcher. In January, 1965, the government was informed by the government of Quebec of certain name changes approved by the province. As far as the Canadian permanent committee on geographical names is concerned, these changes originated with the Quebec geographic board.

2. Name changes are endorsed and recorded by the permanent committee on the recommendation of the provincial or territorial representative and become official when approved by the Minister of Mines and Technical Surveys or the appropriate provincial minister, according to their respective jurisdiction. Name changes are published in the semiannual supplements to the Gazetteer of Canada. The changes listed in 1 (a) above appeared in supplement No. 5, January to June, 1965.
