(c) Selection was made through the continuing staffing program 69-310 in accordance with Section 10 of the Public Service Employment Act which requires that appointments be based on selection according to merit. (d) \$16,379 to \$18,611.

NATIONAL LIBRARY ACT—APPOINTMENT OF ADVISORY COUNCIL

#### Question No. 729-Mr. Dinsdale:

1. Has the Advisory Council, provided for under the National Library Act, been appointed?

2. Who are the members of the Council and what are their credentials?

#### [Translation]

Hon. Gérard Pelletier (Secretary of State): 1. The 9 persons to be appointed by the Governor in Council as members of the National Library Advisory Board under Section 9(2)(d) of the National Library Act have not been appointed as yet by the Governor in Council; the 2 persons provided under (c) have been nominated by the Canada Council and the Association of Universities and Colleges of Canada and their names will be released when all appointments are completed.

2. The present members of Council are the ex officio members, that is Dr. J. G. Sylvestre, National Librarian; Mr. Erik J. Spicer, Parliamentary Librarian; Dr. W. I. Smith, Dominion Archivist and Dr. Jack E. Brown, Librarian of the National Science Library of the National Research Council of Canada.
