Branch is co-operating in this matter with the Food Prices Review Board which is conducting a similar inquiry?

Hon. Herb Gray (Minister of Consumer and Corporate Affairs): Mr. Speaker, if the hon. member will look at my remarks in the House on Monday night, he will see that I said this inquiry is being carried out under section 47 of the act and the results will be presented to the Restrictive Trade Practices Commission.

Mr. McGrath: I asked the minister if the results of the inquiry, in view of their national importance, would be made public and, further, if the Combines Investigation Branch in the course of its inquiry is co-operating with the Food Prices Review Board which is conducting a similar inquiry?

Mr. Gray: Mr. Speaker, I could be wrong but I do not think the work of the Food Prices Review Board, to which the hon. member has referred, is similar. I think the latter is looking at certain pricing practices in retail food stores, whereas the inquiry of the Combines Investigation Branch is much wider and with respect to the food manufacturing industry. On the other part of the question, I will have to check the exact provisions of the law with respect to the work of the Restrictive Trade Practices Commission. I stand to be corrected but I believe that once the report is presented to the commission it is open to it to hold public hearings on the report. However, I will check into that and make sure my information is correct.

NEED FOR ADDITIONAL GRAIN CARS TO CLEAR BACKLOG—GOVERNMENT ACTION

In view of the present situation with harvesting in western Canada and the need for many western farmers to stockpile grain outside because of the backlog and the lack of grain cars, has the department undertaken any discussions with Canadian National and Canadian Pacific to make sure that this backlog will be taken care of shortly, and what is the supply of grain cars coming from Thunder Bay?

Mr. Joseph-Philippe Guay (Parliamentary Secretary to Minister of Transport): Mr. Speaker, this has been one of the main concerns of the minister, but I will still bring the question to his attention on Monday.

HOUSE OF COMMONS

MOTION TO ADJOURN UNTIL OCTOBER 15, 1973

Hon. Otto E. Lang (Minister of Justice) moved:

That, when the House adjourns this day, it shall stand adjourned until October 15, 1973, provided that at any time prior to that date, if it appears to the satisfaction of Mr. Speaker, after consultation with the government, that the public interest requires that the House should meet at an earlier time during the adjournment, Mr. Speaker may give notice that he is so satisfied, and thereupon the House shall meet at the time stated in such notice, and shall transact its business as if it had been duly adjourned to that time; and

That, in the event of Mr. Speaker being unable to act owing to illness or other cause, the Deputy Speaker or the Deputy Chairman of Committees shall act in his stead for all purposes of this order.
