### Oral Questions

Hon. Donald C. ## REQUEST FOR EXPLANATION OF DISAPPEARANCE OF CERTAIN JOBS

In light of the release of the monthly reports of DREE, dating back six months, which indicate that approximately 3,800 jobs have been lost for which the government previously claimed credit, is the minister going to table in the House a more detailed explanation of why these jobs suddenly disappeared?

Hon. Donald C. Jamieson (Minister of Regional Economic Expansion): Yes, Mr. Speaker, this is part of the reorganization I am hoping to undertake.

Some hon. Members: Oh, oh!

Mr. Jamieson: As the hon, member will know, Mr. Speaker, on a projection basis it is impossible to be precise as to the number of jobs, but I think we owe it to the House and to the public to explain what happened in cases such as this.

#### AIRPORTS

HIJACKING—SUGGESTED TRANSFER OF JURISDICTION OVER POLICE OPERATIONS FROM CRIMINAL CODE TO AERONAUTICS ACT—INTRODUCTION OF SPECIAL FORCE

Hon. George Hees (Prince Edward-Hastings): Mr. Speaker, I have a question for the Minister of Transport but I would first like to congratulate him on assuming one of the two most important portfolios in the government.

Some hon. Members: Hear, hear!

Mr. Hees: As police operations at our international airports come under the jurisdiction of the police forces of the municipalities in which the airports operate, which makes it very difficult to deal adequately with potential hijackers and hijacked planes, is the government giving consideration to transferring jurisdiction over these police operations from the Criminal Code to the Aeronautics Act so these matters can be handled by the RCMP?

Hon. Jean Marchand (Minister of Transport): Mr. Speaker, the hon. member for—what riding?

Mr. Baldwin: Prince Edward-Hastings.

Mr. Marchand (Langelier): As hon. members have heard, there is a reference in the Speech from the Throne to the Aeronautics Act. We intend to amend this act so that we will have more power, and you will see, of course—

Mr. Baldwin: More power to the minister.

Mr. Marchand (Langelier): Pardon me?

Mr. Baldwin: More power to the minister.

Mr. Marchand (Langelier): Yes. We know that we have to reinforce security at airports. This is being done in the United States and we intend to do it here, but it is very difficult to give details at this moment.

Mr. Hees: Mr. Speaker, I have a supplementary question for the Minister of Justice. Is he doing everything possible to facilitate the transfer of this jurisdiction from the Criminal Code to the Aeronautics Act, and will he advise the House when he expects to have the special force being trained by the RCMP to operate at our airports ready?

Hon. Otto E. Lang (Minister of Justice): Mr. Speaker, I think at least part of that question would be more properly directed to the Solicitor General. I can assure the hon. member for Prince Edward-Hastings that this matter is receiving high priority within the Department of Justice so far as the drafting of legislation is concerned.

Mr. Hees: Mr. Speaker, I have a final supplementary question for the Solicitor General. Will he advise the House when he expects that the special force which is being trained will be in operation at our airports?

Hon. Warren Allmand (Solicitor General): Mr. Speaker, the force is being recruited right now and some of the men will be trained very shortly. I do not have an exact date when they will be ready for work.
