Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, the attitude of Canada towards the imprisonment and detention of these two men was known from the beginning. We protested their detention. We took every measure we could to get them released. I am very happy, as I am sure all hon. members are that they have been released in good health. Whether we make formal protests is a rather different matter since the Viet Cong are not recognized by us as a government, but we are members of the international control commission and in our future dealings with them we will bear this is mind.

## AGRICULTURE

SUGAR BEETS—POSSIBLE INCREASE IN DEFICIENCY PAYMENTS AND ACREAGE—GOVERNMENT POSITION

Mr. Jack Murta (Lisgar): Mr. Speaker, I would like to direct a question to the Minister of Agriculture. Since sugar beet producers asked some time ago for a 10 per cent increase in the deficiency payments for sugar beets, and in view of the fact that no word has yet been forthcoming from the government on this matter, can the minister state at this time the position of the federal government?

Hon. E. F. Whelan (Minister of Agriculture): Mr. Speaker, we discussed this request just recently. The price of sugar beets, even granting their request for a support price, would not come near what they are going to receive for their sugar beets this year. Therefore, according to what sugar beet growers have told me, the matter is not that urgent.

Mr. Murta: As a supplementary question, can the Minister of Agriculture say if there is any action being taken by the government to increase total Canadian acreage of sugar beets so that our farmers may produce more sugar beets for Canadian consumption?

Mr. Whelan: Mr. Speaker, this was part of the discussion that took place just recently, and we are still considering this proposition. I stated earlier in the House that I am very determined that we will increase our sugar beet production and our refining of sugar beet production in Canada.

## CANADIAN COASTGUARD

POSSIBLE TRANSFER OF NAVIGATION AND ENGINEERING STUDENTS AS WELL AS SENIOR OFFICIALS OF COLLEGES TO CORNWALL OR OTTAWA

Can he advise if instructions have gone out to the Canadian Coastguard College to the effect that third and fourth year navigation and engineering students are to report for the fall term at either Cornwall or Ottawa, rather than at the present location?

Hon. Donald C. Jamieson (Acting Minister of Transport): Mr. Speaker, I will take that question as notice for the minister and get a reply as soon as I can.

Mr. Muir: I wish to thank the minister for replying. Would he also advise if senior officials of the college have been advised to secure housing in either Cornwall or Ottawa by September 1 or thereabouts for the fall term of the college?
