Mr. Crosbie: The House is dissolved.

An Hon. Member: There is no such rule.

Mr. Beatty: Privilege-

Mr. Lawrence: I beg of you to hear us on a question of privilege affecting the constitutional usages and traditions of this House.

Madam Speaker: I have just reminded Hon. Members of the practice of the House. The practice of the House is that points of order and questions of privilege are delayed until after statements by Members and Question Period.

Some Hon. Members: Oh, oh!

Madam Speaker: There are innumerable precedents to that effect, and my only guide—

Mr. Beatty: The procedure is unconstitutional.

Madam Speaker: —under these circumstances is the Standing Orders which tell me that at this time I must hear statements by Members. Hon. Members are asking me to rule on a constitutional matter. It is not up to the Chair to rule on

constitutional matters. The Chair can only rule on procedural matters. Therefore, I recognize the Hon. Member for Lévis (Mr. Gourde).
